Our office has no information regarding Conrad Rockenhouse's whereabouts or welfare. The same applies to Adriene, who has not been regularly communicating with Lisa Baker, the attorney in our office assigned to her matters. Procedurally we can advise that Lisa has been released as Adriene's attorney in the PPO matter. A Motion to Withdraw as Adriene's attorney is pending in the divorce matter. Both the PPO and Divorce matters are public records so we are not disclosing any confidential information. That is all we can legally disclose.

Hi Ms. Baker,

I am frantically reaching out to you because your contact information was taped to the front door of Adrienne Rockenhaus's house in Redford. The note on the door specifically said not to leave papers there and to contact you as her attorney instead.

I am a friend of both Adrienne and Conrad. Something horrific is going on, friends and family are in an absolute panic. Nobody has heard from either of them in a month, and I need to know if you know where Adrienne is and if she is safe.

Here is what is happening: Conrad has been completely missing for a month. Last night, an automated "Dead Man's Switch" triggered and posted to his Facebook page. It basically said that if it was posting, he had not logged in for a month and is dead. [text redacted for privacy]. The only communication anyone has received regarding Conrad recently are these highly suspicious emails demanding money from his friends and family, which are clearly from an imposter who hacked his account or is pretending to be him.

Because we couldn't reach Conrad and the Facebook post terrified us, I tried to call Adrienne, but her phone is going straight to voicemail. None of her friends have seen her post on social media or heard from her in weeks, and we know she has been in severe danger.

I live in Ann Arbor, so yesterday afternoon I drove out to Adrienne's house in Redford to check on her. When I pulled up, the Police were actually there and inside her house!

I asked the officers what the hell was going on, and they told me they were executing a "welfare check" because multiple people have been reporting her missing.

Lisa, the police are in her house, Conrad's Facebook is broadcasting that he is dead, an imposter is trying to extort his family for money, and no one can find Adrienne.

Please, as her attorney, tell me if you know if she is okay. We are absolutely terrified that something has happened to both of them. My number is [redacted]
