You scheduled this hearing for April 29. It is only March 10. The threat to my safety is increasing by the hour, and I will be guaranteed to be murdered before April. What am I supposed to do to survive until then?

The local police (Redford PD) have maliciously banned me from the 911 text system due to my disability and actively refuse to enforce your protection order. Their refusal to act has completely emboldened him and his proxies, who are now physically trespassing at my home and leaving threatening notes on my car, and the police refuse to investigate or help. I am under constant threat. What do I do when the police will not help me, the court delays my hearing for 7 weeks, and a murderer is actively hunting me?

[Author's note: Detroit's Wayne County Court did not offer a single word of human response or substantive help to that horrifying email. Clerk Kimberly Wade received an email where a disabled domestic violence victim explicitly stated a murderer was actively hunting her, and their only response was to complain about which email inbox she used before letting an automated system deny her request. It perfectly encapsulates the depraved malice we are calling out.]

Be advised that Ann Arbor PD/ Officer Stanley report number 26-14521 (made this morning), proves Conrad Rockenhaus is confirmed to be lying about residing at this address. AAPD's Officer Stankey attempted to address the daily terrorization and threats my family and I face from Conrad Rockenhaus as he digitally violates the PPO, instilling fear in us without any consequence. These threats include a direct threat made to my personal Signal Messaging App from Conrad Rockenhaus last night, within minutes after I received this emailed notice from your court. The message he sent me was to taunt me about this court's email. He then proceeded to threaten my friends from his public Twitter account all last night and through this morning. Per Ann Arbor's Delonis Shelter on Huron Street as of this morning (March 28), the Shelter confirmed with Officer Stankey that Conrad Rockenhaus does NOT reside there. You can refer to report 26-14521 with the Ann Arbor police for confirmation of this. Since the respondent has lied to the court about his address, please now reverse the denial for my alternative service.
